## APPLICATION FOR FENCE PERMIT

**INSTRUCTIONS:** Submit one (1) application and two (2) sets of drawings and supplemental information that might be required to assure compliance with the City's fence regulations contained in Section 1165.02 of the Mentor Code of Ordinances. Drawings must include a site plan which indicates:

- ◆ Property lines and dimensions
- ◆ Location of all buildings and/or structures
- ◆ Dimensions of the fence in relation to: building/structures; property lines; the right-of-way of any street abutting the lot; the distance from any fence or building and/or structure on the property abutting the lot.

The site plan may be prepared by a registered surveyor or the property owner. If the site plan is prepared by the property owner, the application must be approved in writing by all contiguous property owners which will abut the fence. Use the signature form at the end of this application. The staff will assist you in identifying the front property line or other property dimensions.


