# Hours of Operation

- \*Fridays 2-6 p.m. (June 18-September 24) RAIN OR SHINE, no refunds for rain.
- \*Vendors may arrive on the grounds no earlier that 12 p.m. Booths must be set up by 1:30 p.m.
- \*Booths must remain up until 6 p.m. –including if you sell out of all of your products leaving early will result in forfeiting your space for the remaining weeks of the season .

#### Fees

- \*\$10 per week prior to May 1, 2021-\$12 if after May 1, 2021
- \*\*\$150 (15 weeks), \$180 if application is received after May 1, 2021 (see booths section below).
- \*\$70 (7 weeks), \$84 if application is received after May 1, 2021.
- \*\$40 (4 weeks), \$48 if application is received after May 1, 2021.
- \*Full payment must be received with application. Payment will not be accepted on site.

## Vendor Eligibility

- \*Locally grown food vendors are able to attend all 15 weeks.
- \*Art and Craft vendors are able to attend the 4 Fantastic Friday dates (see below).
- \*Food Vendors: 75% of all items available for sale must be hand grown or made by you. Market Manager may request information about items.
- \*Product resellers are strictly prohibited (no direst sales or outside groups).

#### Fantastic Fridays

- \*Art and Craft vendors are able to attend 4 weeks: June 25, July 30, August 27, September 24.
- \*Arts and Craft Vendors: all item for sale must be handmade by you.

#### **Booths**

- \*Vendors who attend the entire season (15 weeks) receive a permanent booth spot. Booth space are assigned by order received.
- \*Each booth space is 14x14 feet on a grass surface.
- \*10x10 canopy tent is required.
- \*Vendors supply table and chairs.
- \*Many booths are located in the sun.
- \*One car is able to park behind the booth space for easy unloading and loading.
- \*Booths can not be set up before 12 p.m.

#### General

- \*If you are unable to attend a week, you must notify the Market Manager 24 hours in advance.
- \*Two unexcused absences from the Market will result in forfeiting the remaining weeks of the season and the following season.
- \*Application can be mailed to Mentor Farmers Market, City of Mentor, 8500 Civic Center Blvd., Mentor, Ohio 44060 or emailed to wintersteller@cityofmentor.com.
- \*Credit card payment is accepted over the phone (440) 974-5735.
- \*Send photos with your application to be used in advertising.
- \*2020 highest weekly attendance was 2,000+ shoppers.

- \*The Mentor Farmers Market Facebook page posts a variety of photos and information throughout the season.
- \*Vendors will receive informational emails prior to Market days.
- \*Vendors may not smoke within Market grounds.
- \*Vendors must respect the City of Mentor's property and leave a clean booth space after packing up goods.
