**Fees**

**\*\$10 per week prior to May 1, 2022 - \$12 if application is received after May 1, 2022**

\*\$150 (15 weeks) - \$180 after May 1, 2022

\*\$70 (7 weeks) - \$84 after May 1, 2022

\*\$40 (4 weeks) - \$48 after May 1, 2022

\*Full payment must be received with application. Payment will not be accepted on site.

**Art and Crafts on Fantastic Fridays**

\*Art and Craft Vendors are able to attend 4 weeks: June 17, July 29, August 26, September 23.

\*All item for sale must be handmade by you.

\*Photos must accompany the application, 4 to 5 product and booth display photos

**Booths**

\*Vendors who attend the entire season (15 weeks) receive a permanent booth spot.

\*Each booth space is 13x13 feet on a grass surface.

\*10x10 canopy tent is required.

\*Vendors supply table and chairs.

\*Many booths are located in the sun.

\*One car is able to park behind the booth space for easy unloading and loading.

\*Booths can not be set up before 12 p.m. unless otherwise noted.

\*Credit card payment is accepted over the phone (440) 974-5735.

\*Photos (sent electronically) will be used in advertising.

\*If you are unable to attend a week, you must notify the Market Manager 24 hours in advance.

\*Two unexcused absences for a food Vendor, one unexcused absence for an Arts and Crafts Vendor from the Market will result in forfeiting the remaining weeks of the season and the following season.

\*2021 highest weekly attendance was 2,500+ shoppers.

\*The Mentor Farmers Market Facebook page posts a variety of photos and information throughout the season.

\*Vendors will receive informational emails prior to Market days.

\*Vendors may not smoke within Market grounds.

\*Vendors must respect the City of Mentor's property and leave a clean booth space after packing up goods.

\*Electricity is not available.
