### CITY OF MENTOR OHIO COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM PUBLIC MEETING NOTICE FISCAL YEAR 2020 ACTION PLAN

The City of Mentor is required by the U.S. Department of Housing and Urban Development (HUD) to prepare an Annual Action Plan to govern the use of the Federal Community Development Block Grant (CDBG) funds. These funds must primarily benefit low- and moderate-income persons. Per HUD regulation and the City of Mentor's Citizen Participation Plan, two public hearings will be held by the City of Mentor.

The first public hearing will be held on Thursday, April 16 th at 2:00 PM and will only be accessible online.
