# FARMERS MARKET

**Fridays, 2–6 PM June 21–September 27, 2019**

Welcome to the Mentor Farmers Market, where you can sell your local home grown produce and related products direct to consumers in an open-air market.

**LOCATION:** Eleanor B. Garfield Park, 7967 Mentor Avenue, Mentor

**HOURS OF OPERATION:** 2-6 PM -- RAIN OR SHINE. There will be no refunds. Set up must be completed by 1:30 PM. Booths must remain open until 6 PM. *Leaving early without permission from the market manager may result in forfeiting your space for the remaining weeks.*

**VENDOR ELIGIBILITY:** All vendors in the Mentor Farmers Market must meet the following eligibility requirements:

- 75% of the items available each week must be grown/made by you. Market organizers may request information about items.
- Local is defined as within 75 miles of the City of Mentor.
- In the event that you are unable to attend your weekly scheduled farmers market date, you will need to notify Linda Wintersteller at 440-974-5735 *24 hours in advance*. If you miss more than 2 scheduled dates throughout the season, you will not be welcome back next year.

**FANTASTIC FRIDAYS:** Arts and Crafts vendors are welcome on the four Fantastic Friday dates: June 28, July 26, August 30, September 27.

**BOOTH ASSIGNMENTS:** Assignments are based on a first come, first served basis including the need for a specific product. Product resellers are strictly prohibited. Every attempt will be made to balance the needs of our consumers with the needs of the vendors without overloading the market with similar products. Each booth is 12 x 12 ft.; vendors are required to stay within the space parameters. It is your responsibility to make sure that your 10x10 canopy tent is within your designated area. The market surface is grass. Each vendor will be permitted to park one vehicle near their assigned space.
