hank you for your interest in the 2023 Wildwood Holiday Boutique! This event is a <u>JURIED ARTISAN</u> <u>SHOW</u>. All applications will be put in front of the Boutique Committee for consideration. The committee is looking for original, handmade seasonal art and fine crafts.

ENTRY REQUIREMENTS

- * Vendors MUST submit 4 to 5 current photos of products and at least 1 table display photo(s) <u>electronically</u> to <u>wildwood@cityofmentor.com</u>. Emailed photos must be accompanied with vendor's name and business name in the subject box (if accepted, submitted photos will be used in advertising).
- * After the three pieces of your application have been received (1-COMPLETED APPLICATION, 2-PHOTOS, AND 3-FEES) the packet will be presented to the Boutique Committee to be juried.
- * Checks MUST be payable to the City of Mentor.
- * Vendors will be notified via email of their status in the show after being juried.
- * Failure to meet the above entry requirements will result in your application being rejected.

FEES & LOCATIONS (All fees include a non-refundable \$10 jury fee.)

- * \$75, 1st Floor, one 30"x 72" table
- * \$75, 2nd Floor, one 30"x 72" table
- * \$60, Lower Level Craft Room, one 30"x 72" table
- * \$50, Third Floor Ballroom Room, one 30"x 72" table
- * \$25, Outdoor booth space 14'x14' (vendor must have a tent and table)- Outdoor areas will be back patio along front walkway near the front entrance of the building. These spots are rain or shine and are non refundable.
- * Vendors must use the stairs to access the second and third floor rooms, as well as the lower level craft room, as there are no elevators in the facility.
- * Vendors are only allowed **ONE TABLE** space and are not permitted to sublet their table space *or bring additional tables*.
- * Tables and chairs are provided for indoor vending space.
- * If vendor is submitting an application with a money order or check—they must accompany \$10 the jury fee check along with a seperate vendor space check (ex. 1st floor you would submit a 1-\$10 jury fee and a 1-\$65 vendor space fee)

- * All applications must be submitted with photos, a completed application, and fees to be considered!

- * The Jury FEE IS NON-REFUNDABLE!
- * Outdoor spaces are non-refundable, rain or shine!
- * Notice of cancellation must be received by October 31, 2023 to be refunded less a \$10 admin fee.

- * 7-9 a.m. on Friday, December 1 and/or Saturday, December 2, and December 3 prior to show.
- * You will be able to choose your set up day and time slot closer to the show date.
